**All information is held in strictest confidence.**

- **Financial Information Form:** Complete one per family.
- **Federal Income Tax Return:** 1<sup>st</sup> page of Federal Income Tax Return. MUST be for tax year prior to date on application. IF no filing, please provide "Statement of Non-Filing" that can be obtained from your school.
- **Letters of Recommendation:** From parent/guardian, church/school leader or other, reflecting on student's character, citizenship or school/community involvement.
- **Public School Verification Form (if applicable):** When transferring from an Arizona Public School.
- **Verification of Previous Tax Credit Award Form (if applicable):** NOT required if award received from CSF and all three tax programs – Original, Switcher/PLUS, and Corporate. This provides validation of student's program eligibility.

*The selection committee will consider any recommendations, financial circumstances, and letters about the student in its decision regarding allocation of the available funds. The committee has complete discretion regarding scholarship awards.*

### **CONDITIONS OF ELIGIBILITY**

- The student must:
  - Attend a tuition-based Christian School in the Tri-city area served by CSF.
  - Be in a grade level between kindergarten and 12<sup>th</sup> grade inclusive.
  - Maintain at least a 90% attendance record, unless excused by the school administrator.
  - Maintain at least a "C" grade average.
- The family must remain current on their portion of tuition and fee payments, unless excused by the school administrator.
